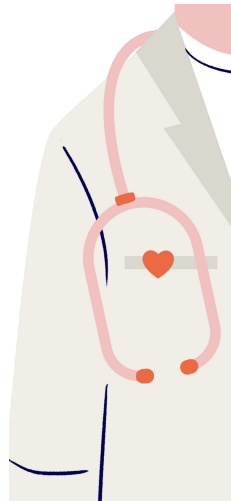
CRC PROVIDER HIGHLIGHT: YWCA
