EVICITION MORATORIUM AND COVID-RELATED PROTECTIONS EXTENDED TO JANUARY 15, 2022

The [executive order](#) protects residential and commercial residents from eviction as well as modifies additional relief measures related to utility assistance.

The state is requiring landlords to offer payment plans to tenants who have fallen behind on rent during the pandemic, working to set up a program offering [free attorneys](#) to low-income tenants facing eviction and offering [relief grants](#) of up to \$15,000 to landlords under certain conditions.

Residential tenants who receive an eviction notice during the moratorium should contact the Renting in Seattle hotline at (206) 684-5700.
